NY State Regulation: In order to complete the required self-study portion of these courses, ALL LAH, L, AND A/H must register at least one week in advance of the first day of class.

CAPE POLICIES

TO PRE-REGISTER: Registration must be accompanied by payment in full. Complete the registration form and **MAIL** (check or credit card) or **FAX** (credit card only) to our office so we receive it at least two weeks before your first class session (LAH, L, A/H only). This will enable you to receive your course material before class. You may register by **PHONE** with a credit card. *Include your fax number/email and Cape will send you a confirmation of registration.*

SCHEDULING: When you pre-register you may schedule all of your courses for a definite date and location, or schedule part now and the rest later. When paying for courses "to be scheduled later" please place **TBS** in the *location* and *date* lines on the registration form on reverse. We will hold these until you decide on a definite date and location.

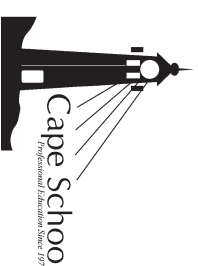
