CAPE POLICIES

TO PRE-REGISTER: Registration must be accompanied by payment in full. Complete the attached registration form and **MAIL** (check or credit card) or **FAX** (credit card only) to our office so we receive it at least 5 business days before your first class session. This will enable you to receive your course certificate on class-day. You may register by **PHONE** with a credit card. *Include your fax number and Cape will fax you a confirmation of registration.* There is a \$20 walk-in fee if you are not pre-registered.

SCHEDULING: When you pre-register you may schedule all of your courses for a definite date and location, or schedule part now and the rest later. When paying for courses "to be scheduled later" please place **TBS** in the *location* and *date* lines on the registration form on reverse. We will hold these until you decide on a definite date and location. There is a \$20 walk-in fee if you are not pre-registered.

RESCHEDULE: Seminars may be rescheduled (space available) with no penalty if Cape is notified in our office one business day prior to the scheduled seminar. "No shows" are allowed one (1) opportunity to reschedule with a \$20 reschedule fee. There are NO refunds for "No Shows".

CANCELLATIONS: Cape reserves the right to cancel classes due to circumstances beyond our control.

REFUNDS: Requests for refunds must be received in our office one business day prior to the start of class. A \$25 non-refundable administration fee will remain on your account for one year and may be applied to future seminars offered by Cape.
